**THIS MATTER having come before the undersigned Judge, and the court having considered the evidence presented herein, renders the following order:**

**IT IS ORDERED** that, pursuant to Title 35 of Louisiana Code of Criminal Procedure Articles 1000 through 1003, LA R.S. 14:95.10, LA R.S. 46:1846, and or LA R.S. 46:2136.3, and Federal Law 18 U.S.C. 922, the defendant is hereby ordered to transfer all firearms in his/her possession. Defendant is also ordered to surrender any concealed handgun permit he/she may possess.

LA C.Cr.P. Art 1000 "Firearm" means any pistol, revolver, rifle, shotgun, machine gun, submachine gun, black powder weapon, or assault rifle which is designed to fire or is capable of firing a fixed cartridge ammunition or from which a shot or projectile is discharged by an explosive.

The defendant shall transfer any and all firearm(s) in his/her possession, control or custody including, but not limited to, the firearm(s) described above. The defendant shall transfer all of his/her firearm(s) within 48 hours of the issuance of this order. If defendant is in custody the transfer must be within 48 hours from the time of release. The defendant shall within **5 days** of transferring firearm(s) file the **Proof of Transfer** form with the Clerk of Court of the parish or city in which the order was issued. If the defendant possesses a concealed handgun permit, the concealed handgun permit is hereby suspended. Defendant must notify the Louisiana State Police within 48 hours of the issuance of this order that the concealed handgun permit is suspended.
